

## Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

**ENTRY:** Enter to win the Chelsea University Online Sweepstakes (the "Promotion") by using Chelsea Groton Bank's ("the Bank") online E-Learning Platform, Chelsea University, and meeting the guidelines outlined monthly on the Bank's Facebook Page.
